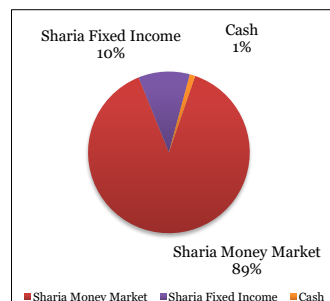
### Investment Manager Profile
